Existing tenants of the former apartment complex will have the option to buy their unit or eventually move. According to state regulation NH RSA 356-C, tenants choosing not to buy their units have either 270 days from receipt of the original notice from the developer or until the lease expires, whichever is longer, before being required to vacate the unit. For elderly or disabled tenants choosing not to buy, the developer must allow 18 months before requiring them to move.

"We hope that tenants choose to stay and take ownership of a piece of this turn-of-the-century property," says Arthur W. Sullivan, principal and partner of Brady Sullivan Properties. "With recent upgrades and restoration, the units and common areas are uniquely beautiful spaces that could make for a wonderful and affordable home."
